Crismon Tree At Home Of Links

An unusual Christmas tree stands in the home of a Warrenton couple the Rev. and Mrs. John Link.

The tree is a Crismontree, decorated with small white lights symbolizing purity, and Crismons, which are homemade Christian symbols. The word Crismon is a compound of Christ and monograms. They had their origin

in the early Christian symbols of faith-the fish, butterfly, the rose, the cross, the circle, the star, the staff, Greek letters for Jesus Christ, the cornerstone, and others.

The Rev. Mr. and Mrs. Link obtained Crismon patterns from the Lutheran Church of the Ascension in Danville, Va., where the idea was originated in 1957 by Mrs. Harry W. Spencer.

Since then, when Mrs. Spenser sought to have a truly Christian Christmas tree for the church sanctuary, the use of Crismon trees has spread to every state in in the union and to many foreign countries.

"It is an excellent way to put Christ in Christmas and to teach the significance of our Christian symbols," Mr Link said.
