

### **Postoffice Windows** To Remain Open

The service windows at the Warrenton Postoffice will remain open until 5 p. m. on the two Saturdays prior to Christmas for the convenience of the public in transacting all postal business, Postmaster A. C. Blalock said yesterday.

All Christmas cards must be stamped with a minimum of 6¢ postage. Blalock said that there is no longer any price differential between sealed and unsealed Christmas cards except with regard to weight. A sealed card must carry 6¢ postage for each ounce of weight; an unsealed card must carry 60 postage for the first two out es of weight. He said that since most Christmas cards weigh under an ounce, it will be to the public's advantage to mail cards first class and receive forwarding and return privileges.
