Norlina Building Burned

Warren Feed Mills at Norlina, built more than 25 years ago by the late W. L. Long and operated for many years by the late Alfred J. Ellington, a former county commissioner, was burned down in 18 minutes at 3 o'clock Saturday afternoon by its owner, Alfred M. Bennett, owner of Bennett's Fire Equipment, who will use the lot as the site of a 2600-square-foot steel building which will be the new headquarters of his company.

Bennett said yesterday that before the building was set on fire

Saturday, that it had been stripped of all its equipment, which had been sold to local farmers interested in making their own feed. He said the rapidity with which the mill burned was due to the large amount of grain dust in the structure.

He said that the rush was because of laying a concrete slab for the new building before cold weather sets in. Space in the new building will be used for storing, working on and testing fire trucks. Completed trucks will also be on display.

Bennett said that he is

highly pleased with the Norlina operation and intended to be from here on a citizen of Warren County. If present progress continues, he added, he hopes to be employing 25 persons within the next two years.
