THOUGHT FOR FOOD

Impossible Pina Colada Pie
 1/4 cup milk
 1/4 cup rum*
 2 tsp. margarine or butter, softened
 4 eggs
 1 can (15 ozs.) cream of coconut (1 1/2 cups)
 1 can (8 ozs.) crushed pineapple in juice, well drained
 1 cup flaked coconut
 1/2 cup Bisquick® baking mix
 1 cup flaked coconut

Heat oven to 350°. Grease pie plate, 10x1 1/2 inches. Beat all ingredients except 1 cup coconut, 30 seconds in blender on high or 1 minute with hand beater. Pour into plate. Sprinkle with 1 cup coconut. Bake until knife inserted in center comes out clean, 40 to 45 minutes. Garnish with sliced pineapple and whipped cream if desired. Refrigerate any remaining pie.

*2 tsp. rum extract plus 2 tsp. milk can be substituted for the rum.
