Judge Ben U. Allen of Henderson presided over the November 28 session of Warren County District Court, disposing of the following cases:

Levi Williams, two counts of failure to comply, court found as a fact that the defendant has willfully failed to abide by the conditions of the suspended sentence and ordered the sentence placed into immediate effect, reducing the sentence to 60 days in jail, defendant gave notice of appeal to Superior Court, bond set at \$200 secured.

William Turner Kearney, failure to comply, called and failed, arrest order issued, bond set at \$500.

Wilbert Hargrove, assault by pointing a gun, dismissed by the prosecutor.

William Levister, two counts of worthless check, defendant ordered to pay the amount of each check for the use and benefit of the payee of the checks, and pay one court cost.

Louis Henry Henderson, four counts of failure to comply, called and failed, arrest order issued, bond set at \$200.
