Historic Home Sold On Friday

An historic Warrenton home, the Green-Polk House, was sold at public auction here on Friday for a bid of \$45,000.

Having the high bid when the auction ended was James Ross, an executive with Burroughs Wellcome of the Research Triangle Park.

The house, located on North Main Street, and about five acres of land were auctioned by three attorneys.

There is a ten-day upset bid period.

Named as commissioners in the special proceedings for sale in lieu of partition were Marvin P. Rooker and Lewis A. Thompson, both of Warrenton, and Cary Whitaker of Roanoke Rapids.

Noted as an outstanding brick Greek Revival house with unusually large windows and a handsomely carved front door, the Green-Polk House was built about 1850 for wealthy planter Nathaniel Turner Green. It was later the home of Mary K, Williams of the great plantation Montmorenci, then of her grandson, Tasker Polk, prominent Warrenton attorney.

Two Men Charged With Break-Ins; Other Illegal Entries Are Reported

Two men, arrested recently by the Warren County Sheriff's Department following official investigations of area break-ins and thefts, will stand trial today (Wednesday) in Warren County District Court, but other persons —an unknown number of whom played "grinch" and swiped Christmas gifts—continue to elude local officials.

Ralph Allen McCoy, 25, of Rt. 1, Norlina, was arrested on Dec. 18 following the investigation of the break-in and theft at the Warren Plains cabin owned by Warren County resident Charles Davis and Mrs. Laura Davis-Lehman of Florida. The cabin is located off R.U.P. 1322. \$5,000 bond since his arrest by Deputy Harold Seaman on Tuesday.

Wilson is charged with two break-ins that occured last Wednesday. One break-in occurred at the Rt. 2, Norlina residence of Charles Cooper. Deputy Harold Seaman was the investigating officer. The other break-in occurred at the Rt. 2, Norlina residence of Mrs. Clementine Dale Jones.

Deputy J. M. Alston was dis-

located on S.R. 1001. The persons, who gained entry by entering a sliding door at the back of the building, ransacked the residence and ripped open wrapped Christmas gifts, the report stated.

Child-support collections in Warren County have increased to an all time high of \$721,022.78, Clerk of Court Richard E. Hunter, Jr. announced this week.

According to Hunter, the increase is due in part to a fouryear-old law that provides more collection power to local court officials.

Hawks, who will become a program specialist with the N.C. Division of Aging, will work his last day here on Jan. 4.

Yanceyville Attorney Enters Race For Seat In 22nd House District

R. Lee Farmer, a Caswell County attorney, has entered the race for the N. C. House of Representatives from the 22nd District. The Yanceyville native is seeking one of three seats in that district. The Democratic Primary Election is scheduled for May 3.

Farmer began practicing law in Caswell County in 1973 and is currently a partner in the law firm of Farmer & Watlington of Yanceyville. Farmer has served as County Attorney for Caswell County since 1973 and is immediate past president of the N. C. County Attorneys Association.

Farmer says he is entering the race for the State House in order to help improve education in the region as well as to be more instrumental in the process of economic development in the area. He also sees the criminal justice system and senior citizen issues as especially important in the 22nd House District. A graduate of Elon College and the Wake Forest University School of Law, Farmer is married to the former Elizabeth L. Mundy and has three children. His activities in Democratic party politics range from serving as

county Democratic party chairman until 1981 to serving on the N. C. Democratic Executive Committee.

In state government, Farmer was a six year member of the N. C. Criminal Code Commission and has served on the State Judicial Nominating Committee (Division II).

Farmer is a member of Prospect United Methodist Church in Caswell County and serves on the official Board of the church. He is active in the Boy Scouts of America and currently serves as General Counsel for the Cherokee Council of the Boy Scouts of America. He also serves as a member of the Board of Directors of the Piedmont Technical College Foundation.

The 22nd House District consists of Caswell, Person, Granville and Vance counties as well as Roanoke Rapids and Littleton precincts in Halifax County and seven northern precincts in Warren County. There are no suspects in the crime for which Deputy C. R. Adcock is the investigating officer. Last Wednesday, two other

Minor Accidents Occur In Norlina, Warrenton

A couple of minor accidents in Warren County kept Norlina and Warrenton Police Departments busy this past weekend.

The first accident occurred in Norlina at the intersection of Hyco Street and U. S. 1. Driving a 1986 Oldsmobile, Ms. Gwendolyn Rose Allen of Norlina was at the stop sign on Hyco Street. She pulled out onto U. S. 1 into the path of a 1982 Pontiac being driven by Ms. Dorothy Mae Epps of the Pines Apartments in Norlina. Both drivers applied their brakes in an attempt to avoid collision, but their attempts failed.

Damages to Ms. Allen's vehicle were to the front right fender area, while damages to Ms. Epps' vehicle were to the left side. No estimate of the damage was made.

Two passengers riding with Ms. Epps sustained minor injuries from the accident. They are Ms. Rachael Hargrove and Miss Wanda Epps, both of the Pines Apartments.

Ms. Allen has been charged with a safe movement violation. Chief Charlie Galantis of the Norlina Police Department was the investigating officer.

The second accident occurred in Warrenton at the intersection of Fairview and Front streets. Maurice Malone Crump of Manson was traveling toward Main St. on his 1985 Audi and failed to stop at the stop sign at the intersection. He drove into the path of Wilson V. Somerville, Jr. of Rt. 1, Warrenton, who was driving a 1980 Pontiac Sunbird. Crump's vehicle was hit and knocked into a utility pole.

Officer Sara Solorz of the Warrenton Police Dept. was the investigating officer. She charged Crump with failure to stop at a stop sign.

No estimate of the damages to the vehicles was received.
