

# District Court Session Is Held

Judge C. W. Allen, Jr. presided over the April 6 session of Warren County District Court, disposing of the following cases:

Roy Alston, damage to personal property; ordered confined in the Warren County Jail for four months. Defendant in open court and through counsel gave notice of appeal to the next session of Warren County Superior Court.

Ada Lynne Babb, speeding 68 in 55 mph zone; found guilty of speeding 64 in 55 mph zone, ordered to pay a fine of \$10 and court costs.

James W. Bailey, two charges of non-support of illegitimate child; voluntary dismissal.

Oscar Ray Baker, speeding 69 in 55 mph zone; found guilty of speeding 64 in 55 mph zone, ordered to pay a fine of \$10 and court costs.

James Ball, Jr., resisting/obstructing a public officer, assault on a law officer, damage to personal property, speeding 68 in 55 mph zone, driving while impaired and no driver's license; called and failed, order of arrest issued, triple existing bond ordered forfeited.

Lorenzo Donnell Ball, driving while impaired; found not guilty.

Sentence suspended for 12 months and defendant placed on unsupervised probation for 12 months; defendant ordered to pay a fine of \$125 and court costs, complete 48 hours of community service within 60 days and pay the \$50 fee, complete the Alcohol and Drug Education Traffic School and pay the \$100 fee, and not operate a motor vehicle on the highways of N.C. until allowed to do so by the Department of Motor Vehicles.

C. until allowed to do so by the Department of Motor Vehicles, obtain a substance abuse assessment from the Warren County Mental Health and abide by any treatment program that is recommended, pay \$100 on or before May 4 and a like sum on the fourth day of each month thereafter until paid.
