#### THE POOR MUST PAY

"One of the gravest indictments of the Congress which has just adjourned is its refusal to think about our terrible tax mess," writes John T. Flynn in a syndicated article. "This responsibility belongs to no special party-both great parties ran away from the subject. A politician is more frightened by taxation than by any other form of menace." During the last fiscal year, Federal, state and local taxes collected in the United States amounted to \$12,500,000,000. If every person who had an income of \$25,000 a year or more, had been taxed to the limit—100 per cent—collections would have reached less than \$4,-000,000,000, one-third of the tax load. 


