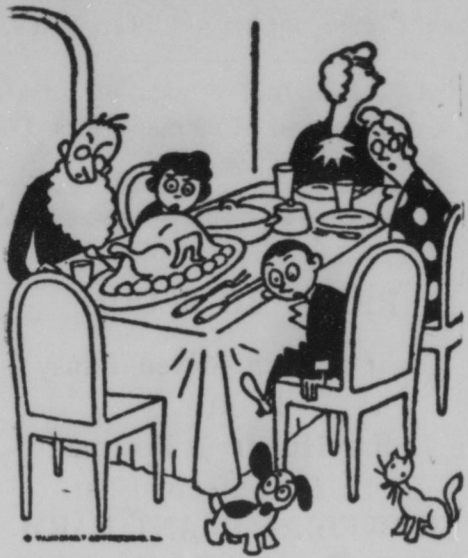


Where's Elmer?
