THIS IS MY BIRTHDAY.
 October 18.
 Frederick H. Gillett, representative in Congress from the Second Massachusetts district, was born in Westfield, Mass., Oct. 18, 1861. He attended the local schools and then entered Amherst College, graduating with the class of 1875. He then entered the law school of Harvard University. He received his degree in 1877 and in the same year was admitted to the bar and began the practice of law in Springfield, Mass. Mr. Gillett was appointed assistant attorney general of Massachusetts in 1879 and served in that office until 1882. In 1890-91 he was elected a member of the Massachusetts legislature and the following year was elected to Congress on the Republican ticket. He has been re-elected every two years since.
