Yesterday morning at St. James Lutheran Church Mr. John L. Morgan, of St. Matthews Church in Rowan county, was ordained as a minister in the North Carolina Lutheran Church, The services overe under the direction of the officers of the Synod and were attended by a large congregation. Mr. Morgan is a graduate of Lenoir College and the Lutheran Theological Seminary at Columbia, S. C., and is a young man of ability and promise.

Members of the Synod also filled various pulpits in the city. At St. Andrews' Lutheran Church. Rev. H. W. Jeffcoat, of Hartshorn, preached at 11 a. m. and at Cavalry Lutheran Church Rev. M. D. Bodie, of Granite Quarry, preached at 8 o'clock.

Rev. M. L. Ridenhour, of Salisbury, conducted the morning . service at Trinity Reformed Church.




