Conditions in India Favor Cotton Planting. Cotton planting in the Punjab province of India has begun under generally favorable conditions, according to a cablegram received by the United States Department of Agriculture from the International Institute of Agriculture at Rome. The moonsoon started a week earlier than usual this season and up to the present time has been generally active and well distributed.

The acreage planted to cotton this year is expected to be 7 per cent above that of last season. The first acreage estimate for India last season was 12,713,000 acres and represented 48 per cent of the final estimate of the total acreage which was placed at 26,461,000 acres.

PICKWICK DEFENDANTS ACQUITTED OF MANSLAUGHTER

Jury Returns Verdict of Not Guilty in Case of Building Inspector and Construction Foreman.

Boston, Aug. 13.—James J. Hendrick, city building inspector, and Lawrence Perkins, foreman of a construction company, charged with manslaughter in connection with the collapse of the Pickwick Club building July 4, in which 44 persons lost their lives, were found not guilty by a jury in Suffolk Superior Court late today.

The jury returned the verdict after three-quarters of an hour's deliberation. The defendants were placed on trial four weeks ago, after the Grand Jury had returned manslaughter indictments. Eight were discharged on directed verdicts in the course of the trial.

The Pickwick Club building collapsed while a dance was in progress early July 4. The indictments charged the defendants with manslaughter in causing the death of Patrolman Paul Haloran, one of the victims.

Guard Smokes While Doctor Cuts Off Foot. New York, Aug. 13.—Patrick Monegon, 42, a guard on the Hudson & Manhattan Railroad, smoked cigarettes at the Hoboken tube station today, while a surgeon from St. Mary's Hospital amputated his foot without administering an anaesthetic.
