

O'Briant's court Percy Swanson, of Carrboro, was tried for obtaining marriage license by false representation and perjury for the marriage of Miss Moline Hughes of Carrboro. On Saturday night before the defendant applied for license, representing the young lady was 19 years of age. Mr. R. M.
