WHITEN SNOWED UNDER

Notwithstanding Saturday was not a favorable day for voting there was a very full vote polled. The only contest of note was that for Clerk of the Superior Court, between D. W. Bradsher, the present incumbent, and J. M. O'Brian. While the odds were always in favor of Judge Bradsher, it was generally conceded that the race would be close. But the result showed that it is never safe to bet on an objection.

The County stood squarely behind Mr. C. A. Hall, candidate for Solicitor, but Durham commands too much voice for any man in the district to hope to win, that is, when Durham has a candidate. While Mr. Hall carried the County by a good majority, the district went against him for about 6000.

We have invited several speakers to be present, and besides the visiting speakers we want to have a round-table discussion. So come with anything on your mind in which you are interested. We want a good crop and ought to have it as every home should be interested in a home garden. If he never intends to grow anything for market, I know there are some who will say, "I always have a good garden. That meeting will not help me any." I just want to say, I know most good farmers have plenty of beans, cabbage, tomatoes and potatoes in season, or about four months in the year. That's all right for one-third of the year, but we could have some vegetable on our table every day in the year if we would only try, and that is the object of this meeting.

You have always heard it said, the garden is the most profitable piece of ground that is cultivated on the farm. We can double this profit very easy, so come to the meeting Saturday and let's get Person County on as a vegetable year next year.

I know there are some few growing truck for market this year, but we were late organizing and got a late start, but we want to start this fall—which is the proper time to start, and see what we can grow.

Increased Fire Insurance Rates Are Found Justified By Commissioner Stacey W. Wade

Raleigh, June 5.—Increased fire insurance rates, as promulgated by the Southeastern Underwriters Association for North Carolina, are justified by conditions existing in the state and will be allowed without protest, so far as the state is concerned, Stacey W. Wade, State Insurance Commissioner, declares in a formal announcement made public Saturday. The announcement is concurred in by Frank Nash, Assistant Attorney General.

The findings contained in the announcement result from the facts furnished the Insurance Department before and during the hearing of last Wednesday on the question of the increased rates, at which Secretary

retary Raine of the Underwriters Association, along with various other insurance agents and officers of local companies, presented the case for the increase, and officers and members of the Raleigh Merchants Association, with their attorney, General Albert L. Cox, appeared as protestants.

Proof was furnished by the Underwriters, the announcement says that fire losses and expenses of doing business in North Carolina cost fire underwriters \$104.00 for each \$100 received and that the merchant rate, upon which the 10 per cent increase has been applied, represented an actual loss of 10 per cent.
