Oliver, Specialist in Poultry, State College, will be the main speaker of the day at the special poultry meeting of all interested in this phase of farming at the court house Saturday, March 10th, at 2 P. M. This is the sixth special meeting held recently in interest of different farm projects, and as poultry is kept on practically every farm in the county, there should be a large gathering to hear Mr. Oliver discuss the important subject on how to get the most from our farm and commercial flocks.

Stock Of Merchandise Belonging To Cantor's Dept. Store Virtually Destroyed STORE BADLY DAMAGED

Sunday morning at 12:15 the fire alarm was sounded and the fire was found to be in the building occupied by H. Cantor and The Featherston Company. It started in the roof, between the roof and the ceiling, and, of course, was hard for the firemen to get at, but the fire-boys fought it with their usual energy. At one time it appeared that there might be need for assistance and Durham was called, and as usual responded promptly, though the fire was under control before they arrived. Roxboro is deeply grateful to the Durham fire company for their splendid response, always coming when called, and coming promptly. The building belongs to Mrs. Mamie Merritt, and was considerably damaged. The stock of merchandise, belonging to H. Cantor was virtually destroyed. He carried a large stock and his loss will be heavy, though he was covered by insurance. Also the stock belonging to The Featherston Company was badly damaged, though not to the extent of the former, and was covered by insurance. The stock of goods belonging to S. & J. G. G. friend was slightly damaged by water. Many examples of Person, Caswell and Orange Counties will be provided with an opportunity to secure treatment by an orthopedic specialist that will remove a part if not all of the physical handicaps of many. This Clinic is in charge of Dr. Walter Cole, Orthopedic Specialist and is conducted under the supervision of the N. C. Board for the Rehabilitation of cripples. LEVINE ARRIVES SAFE IN HAVANA

Havana, March 6.—The American monoplane Columbia, carrying Charles A. Levine, Wilmer A. Stultz and Miss Mabel Boll arrived here today from New York at 1:32 p. m.

Arrival of the transatlantic monoplane—Columbia in Havana marked the first non-stop flight from New York to the Cuban capital, a distance of approximately 1,400 miles. Miss Boll, sometimes called "the queen of diamonds" last summer, was refused to have offered as much as \$50,000 to be piloted across the Atlantic. The party, with Stultz acting as pilot, took off from Mitchell field at 11:30 o'clock last night, making the trip in 13 hours and 56 minutes.

GREAT HELP TO ROXBORO

The 7th annual meeting of the Roxboro Building & Loan Association met last Saturday in the office of the Secretary. The report showed the association to be in most excellent condition, having earned the past year a little more than 7 per cent. This is a fine showing, as only four other associations in the state have a better record for earning than the Roxboro association. At no time during its existence has it earned less than 7 per cent, and one year earned better than 8 per cent. The total assets of the association today, of rather of Dec. 31st, 1927, was \$435,883.21, and the number of shares outstanding on that date was 2503.

Roxboro People Hurt In Auto Accident

Information was received here yesterday of an automobile accident which came very near having fatal results. Robert A. Jackson, who is now living in Durham, and his two sisters, Mrs. M. P.
