

St. Johns, N. F., June 5 .- A report from Trespassy tonight announced unfavorable weather over the Atlantic Ocean made it appear unlikely that the monoplane Friendship would take off vicenorrow on its projected flight to Europe. Miss Earhart Boaton social worker

the eastward air crossing of the Atlantic, was said to be chafing at the delay and anxious to get started at the earliest possible moment.

Trespassy, N. F., June 5 .- The Fokker Monoplane Priendship in which Miss Amelia Earhart, of Boston, hopes to be the first woman to fly across the Atlantic Ocean was ready for the long and hazardous fight late to-day and awaited only the abatement of unfavorable winds before taking the air.

While Miss Earnart and her two male companions. Wilmer Stutz, pilot and Louis Gordon, mechanic, grew impatient, over their enforced delay, Northwest winds swept the harbor here throughout the forenoon and made it impossible to refuel the plane until this afternoon. The tanks were finally filled during a lull in the gale. Except for the high wind, the weather conditions appeared favorable for the flight. The visibility vas excellent
