

SEEMS CONCLUSIVE THAT MAGISTRATES ARE PUT OUT OF BUSINESS. NOUT OF BUSINESS. NOUT OF BUSINESS. The Enterprise yesterday discussed the question now at issue here whether or not under the new charter the Recorder takes away the jurisdiction of Magistrates in the city. The constitu-tion leaves the matter open to argument, but the Supreme Court has already decided the matter which gives the Recorder exclusive jurisdiction. The Enterprise has gotten the following opinion from a pominent lawyer in the State: My Dear Mr. Farris: Following a conversation with you over the 'phone this morning, I investigated the question of the jurisdiction of your Recorder's court. You stated to me that the act gave to the court exclusive original jurisdiction of certain misdemeanors within the limits of the city of High Point, but of course I am at a disadvantage in not having the act before me. You stated that some person had been tried before the Magistrate and that you thought they would adopt this plan of escaping a trial before the Recorder, setting up when tried before the Recorder a plea of former jeopardy. You will notice that Article 4 section 2, of the Constitution of North Carolina provides for our system of courts including that of justice of the peace. You will notice that also article 4, section

27 provides for the jurisdiction of the justice of the peace. However, these two sections in this case can be construed with section 1 4of the same article providing for the establishment of spe cial courts for the trial of misdemeanors in cities and in towns Our Supreme Court has passed on this question in the case of State vs. Baskerville, 141 N. C., page 819. This was a case in which a party was indicted before a magistrate in the city of Kaleigh after the establishment of the Recorder's court at that place. The act establishing the Recorder's court gave to it exculsive jurisdiction of all misdemeanors, etc., within Raleigh township. The court de-







