It is generally accepted to short crops and low prices. But that cause which operates to some extent, does not entirely account for the present scarcity...

There must be some other operating cause. Prices surely are low and crops short, but if money were cheaper times would not be so hard.

It is mainly owing, we believe, to the price of money and the reputation of money lenders.

By various contrivances and ingenious devices for evading the legal restrictions upon currency, the price of money with us is at the exorbitant rate of interest of 20 per cent.

And a high rate of interest, then, has caused the scarcity of money and the consequent depression of trade money can be obtained at four or five per cent and producers are able to pay through the period of six or eight months at low price with but little interest.

But here the exorbitant rate of interest brings about a depression of the price of public securities. If the price of the country will be in the hands of extortionate money changes.

The six counties on the north side of Albemarle sound are not the only ones in North Carolina where extortionate rates of interest are bringing about destruction to the farming and business interests.

The Shylocks and money changers are not alone responsible for this. It is the result of unwise legislation that has in a measure destroyed confidence between the farmer and the money lender.
