

BULGARIA ALSO.

She Joins Greece in War Against the Turk.

Declared War Yesterday. Osman Pasha Commands. The Hero of Plevna in Charge of Turkish Forces. Furious Fight on the Bridge at Arta. Reinforcements Being Hurried to the Front.

New York, April 24.—Special dispatch this afternoon says that Bulgaria has declared war against Turkey.

Constantinople.—It is definitely announced that Osman Pasha, the hero of Plevna, has been appointed commander-in-chief of the Turkish army, having his headquarters at Arta. Ethem Pasha has been recalled.

Osman Pasha won great distinction in the Russo-Turkish war by his defense of Plevna against the Russians. He was born at Tokat, Asia Minor, in 1834, and received his education at the military schools of Constantinople. He has had great experience as a fighter and was in the Crimean war, the Cretan campaign and the Serbo-Turkish war. At the outbreak of the war between Turkey and Russia he was placed in command of the Fifth Army Corps which did great fighting. He was defeated at the battle of Sedivler, and then entrenched himself in Plevna, which he held from August 3 to December 10, 1877. He surrendered with 40,000 men. He has since been Minister of War several times and also occupied the post of grand marshal of the palace. Osman Pasha is in personal appearance and character a typical soldier of the Ottoman Empire, being fanatic, and brave and very frugal. He is regarded by one of the most invincible soldiers of Europe in a fight behind earth works, being more of a defensive than offensive general.

Osman Pasha for some time past has had the honor of being selected to taste all the dishes served to the Sultan and to see that they are safely conveyed into the kitchen for his Majesty.

An additional force of Redifs, or reserves, has been called out to reinforce the Turkish troops operating against the Greeks. They consist of the Koukluk brigade, from Cretan, a division from Smyrna, belonging to the thirteenth army corps, and a division of the fifth army corps. These met will total up seventy-two additional battalions of troops, numbering 50,400 men.

Arta.—During the fighting on Tuesday, the Turks at day-break attempted to capture Arta by assault. Their artillery had been brought up during the night and placed in position on a commanding elevation opposite the town. Under the cover of a furious cannonade, the Turks advanced upon the bridge, and were received with a murderous rifle fire from the Greeks. The Turks made several attempts to cross the bridge, but in spite of their desperate efforts the never succeeded in getting further than the center of the bridge. There the Turkish commander fell dead and, under the terrible fire of the Greeks, the Turks fell back in dismay. Sometime after wards the Turkish guns were silenced in spite of this reserve. The Turks renewed the assault during the afternoon and further desperate fighting followed. The Greeks, sheltered in their trenches fought gallantly and held their own although, since the outbreak of hostilities on Sunday, the Greeks had not for a moment quitted their posts in the trenches.

A Greek officer who says he was a eye witness of the affair, asserts that the attack which the Turks made upon the Greek positions west of Arta a number of miles from the front of the Turkish lines in expectation that the Greeks would refrain from returning the fire of the Turks for fear of wounding the women.

Advices received here today from Arta say that even the women are volunteering to do battle with the Turks.

LONDON.—A dispatch to the Standard from its correspondent at Constantinople says: "The Russian government has sharply ordered Bulgaria to keep quiet while she mobilizes her troops tomorrow (Saturday) unless certain concessions are granted her."

POWERS TO INTERVENE.

They will probably suggest an armistice acceptable to both combatants. Greeks Defeated at Larissa.

LONDON.—What seems likely to be the last week of war is entered upon. Following the Greek defeat at Larissa, London opinion today is almost unanimous that the end is in sight, and this view is probably shared by the powers, as they are already moving to intervene.

It is believed that intervention will first take the form of a suggestion of armistice, to which the combatants would not doubt agree.

The British foreign office has been in close communication with the other members of the European concert, Great Britain suggesting that the time has now arrived for them to act.

The French, German and Italian governments have already responded offering to agree, though the German government adds as a condition that it will be necessary first to exact a pledge from Greece to obey the mandate of Europe when this mandate is again given.

Special dispatches from Athens say that after a desperate battle at Mati, the Greeks were outnumbered, and retreated with a heavy loss, abandoned Tyrnavos and Larissa and removed their headquarters to Pharsalos, a small town on the right bank of Pharsalos, and in the north foot of a spur of the Classical mountains. Pharsalos is about twenty miles due south of Larissa.
