DURHAM ON FIRE.

Breaks Out in the Durham Tobacco Prize House.

Spreads to Seven Other Tobacco Barns and Nine Residences, Eight Called on for Help. 25 Miles Made in 37 Minutes. Under Control.

RALEIGH, N. C., October 1. A 20-ft fire broke out in the Durham tobacco prize barn at Durham, N. C., at 11:35 this morning and burned for about seven hours. The fire spread to nine residences, which were consumed. Over four million pounds of tobacco were burned to ashes. The total loss, probably half a million dollars, which will be covered by insurance. The fire burned for about seven hours. Raleigh was called for and sent a steamer with fire men and a lot of hose. The twenty miles to Durham was made in thirty-seven minutes. The fire was under control by 10:30 in the afternoon. The Raleigh firemen were housed at Hotel Carolina, the Durham firemen at the Park Hotel. The water supply is very low and was of little use in fighting the fire.
