THE PASSING OF THE CIGARETTE.

It is not surprising that the public show that there is a general feeling of falling off in the consumption of cigarettes, and an immediate response will be appreciated by the Journal.

No doubt this feeling will be the result of the anti-cigarette legislation, and it is to be hoped that the sale of cigarettes to minors, legislation looking to the same is pending in thirty or thirty-five States, while seven States are discussing the prohibition of the cigarette from within their boundaries.

Thus in thirty-two States the cigarette is actively opposed, and the law is sought to drive it away or exterminate it.

In addition to the law working against the cigarette, and a more potent force for its passing away, is the action of employers of labor who refuse to employ users of the cigarette.

This action will be followed by more employers of labor there is no question, and in this way the cigarette will find its influence rapidly taken away as being in demand by consumers of the tobacco in its seductive and dangerous form.

The failure of the law, which prohibits the sale of cigarettes to minors, which has been tried in several States, has aroused public sentiment against the sale of cigarettes, as its use by the young has been especially detrimental to their health.

This failure to protect those who were in peril by using the cigarette has made the feeling that the cigarette should be made to go together.

And with this public sentiment being more fully aroused the end of the really made cigarette cannot be distant.

And outside of the manufacturers it is doubtful if there will be any other force over the passing of the cigarette. The users of the cigarette are making the great protest against the legislation which seeks its extermination.

ARE PARTY AND PRINCIPLE SERVED?
