

The balance of trade in favor of the United States in that period was \$492, by the army in China. 224 094, against \$364 219,897 for the corresponding months last year being an increase of \$128,205,097.

For the month of February the exports were valued at \$112,947,361, a decrease of \$6,479,694, and the imports at \$68,927,265, a loss of \$4,905,676, compared with the same month last year.


