PANAMA CANAL TOLL FIXED

Minimum Not to be Below The Amount Sufficient to Maintain and Operate Canal.

Washington, March 11.—Fixing the maximum Panama Canal tolls at \$1.75 a ton, with a minimum not below an amount sufficient to maintain and operate the canal and with preference to be given to American ships, the House committee on interstate commerce by a vote of 14 to 4 agreed on a bill for the operation of the Panama Canal.
