THE TAFT VICTORY AT CHICAGO.

The victory of W. H. Taft over Theodore Roosevelt at Chicago was no surprise to the close student of politics. It was preaged on the test vote for temporary chairman, and each session of the convention following, made the end more certain.

To those looking for the spectacular, the Chicago convention has been a disappointment. It was no epoch making period in the history of the Republican party. It was a prolonged convention, because of the acute antagonism upon which it entered, made long and dreary because the President's side expected tumult and rough riderism, therefore a course was pursued, steady, sure and fatal to the Roosevelt side, and this very undemonstrativeness of the Taft followers took the steam from their opponents, who lacked in the real enthusiasm for their candidate, that is so vital for success. The "steam roller" was too regular. It moved forward and each turn there was a crushing out of some Rooseveltian chance. Party organization can be sneered at, outside the convention but not even a Roosevelt can face it unmoved in a convention. The very weakness of the Roosevelt delegates claims were too apparent when brought before the Republican committee, shaking the nerve of those who had attempted the bluff of forcing their recognition.

The continuation of the Roosevelt campaign tactics before and during part of the Chicago convention, lost their force when confronted by the Taft crowd in control of the convention. Thief, fraud, bolt lost their effect, did not stir the Taft crowd to reply, and failed to arouse any lasting enthusiasm in the Roosevelt faction. Looking backward it is now apparent that the shadow of the convention hall from the first hour had a weakening effect upon those who promised to make the convention an epoch making one in political annals.

THE FORCE OF DIRECTION.

The Horace Greeley advice given over 50 years ago "Go West, young man," would never have found such ready acceptance, except for the tremendous efforts made by the transportation companies to make going West, easy and cheap. This immigration help continues, and the result is seen that the tide is westward, more than to the South.

Notice is lately given of the meeting of officials of Western trunk railways and of the United States Reclamation service at Chicago, to plan a new impetus to attract settlers to the West. It seems that the newly irrigated lands in the West are not getting settlers fast enough, a disappointment to the railways and those who have these lands.

The free homestead law of 1862 with its attractive that thirteen states have been formed in it since that time, or as many as were in the whole country at the outset in Washington's presidency. Two of these states have been created within the past few months, a fact which ought to help the movement to bring more settlers into the trans-Mississippi region. Oklahoma has been increased 100 per cent in the past decade, and Washington 150 per cent. The national irrigation law of 1902, which is effectively supplementing the free-homestead law of 1862 to outdo the government

MEETING HELD LAST NIGHT

Chamber of Commerce Discusses New Railroad Facilities for New Bern.

At a called meeting of the Chamber of Commerce at the court house last night several matters of interest to this city were discussed.

Deplorable was the fact that only a small number of the members of the Chamber were present. The meeting had been well advertised and every member urged to attend, but only about thirty were present and assisted in the proceedings.

The meeting last night was held for the purpose of getting the Atlantic Coast Line Railroad Company to give New Bern some connections over that line with the North. After the reading of a resolution to this effect a number of the gentlemen present gave their experiences in shipping by the Norfolk-Southern Railroad Company and which has been very unsatisfactory.

Mr. L. D. Moore urged that the Coast Line Railroad Company be asked to open up this route. That he thought there was a sufficient amount of business to warrant them doing this. He also urged the Chamber of Commerce to offer them a location for a new warehouse and to offer them some inducement to build it at a more convenient point than at present.

A committee composed of Messrs. Chas. Ives, Clyde Eby and E. K. Bishop were appointed to look over the following resolutions, investigate the existing conditions and report to a call meeting of the Chamber of Commerce.

"Whereas, the transportation facilities are inadequate for the volume of business now transacted at New Bern, N. C. and

Whereas, there is only one northern railroad connection to the city of New Bern thus eliminating competition in shipments to and from the north; and

Whereas, the truckers in the vicinity of New Bern repeatedly complained of the slow schedule now in vogue between New Bern and northern points; and

Whereas, the freight depot of the Atlantic Coast Line is now situated at a point in New Bern inconvenient to the general public in the city of New Bern, be it

Resolved, That the Chamber of Commerce of New Bern, N. C., at a special meeting, June 21st, 1912, respectfully petition the Coast Line Railroad to give the city of New Bern a northern outlet for its freight and passenger traffic and also to locate its freight warehouse in New Bern at a point more convenient than the one now located at New Bern.

Resolved further, That should the Atlantic Coast Line give the city the aforesaid northern outlet, and locate its warehouse at a more convenient point, we pledge to the aforesaid Atlantic Coast Line our support, believing that this investment on their part will be a profitable one."

Mr. Williams urged that those who could represent the New Bern Chamber of Commerce at the N. C. Press Association to be held at Morehead City on July 26th and 27th to let him know during the next few days so that he could make arrangements for them.
