

Assistant Attorney General **Renders Decision**

Says Caswell Messenger Is " Proper Vehicle For Legal Notices."

The report has come to us that some legal advertising and notices have been withheld from the columns of The Messenger because it is being printed out of the county. On hearing this we wrote to the Attorney General of North Carolina for his opinion and decision in the matter. Assistant Attorney General, Frank Nash, replied to our letter saying that The Caswell Messenger is a "proper vehicle for the publication of legal notices." This settles the matter, and no one need hesitate to publish any legal advertising or notices whatsoever for fear that they would not have full force in law, or would not be valid, or would be illegal in any sense of the word. Notices and advertising published in The Caswell' Messenger are of full force in law, and meet with all the requirements indicated by the law.

The letter of Assistant Attorney General Nash on this subject is printed in full below:
