

first Saturday in December. The election for president, vice-president, secretary, and treasurer of the association, manager and sub-managers of the baseball team, manager of the track team, and all other officers of the Association shall be held on the first Saturday in May. But these o' ficers, with the exception of the managers and sub-managers of the different teams, shall not take their seats until the following year.

Sec. 6. The president of the Asso ciation shall advertise the election of officers at least forty-eight hours be fore hand, in the manner prescribes for advertising other meetings.

Sec. 7. The management of the Association's business shall be intrusted to the following officers and committees: president, vice-president, secretary, treasurer, manager and at least two sub-managers of the football tean . manager and at least two sub-man: gers of the baseball team, manager of the track team; committee on finance committee on recommendations, com mittee on rules and regula tions, committee for the awarding o sweaters, and such special committees as may be appointed by the presiden of the Association for the transacti n of particular business.

Article 5 - Duties of Officers and Committees.

Sec. 1. President. (a) No person shall be eligible for president or the Association until he shall have lived at this University for a period of three years. (b) The president shall ca and preside over all meetings of th Association; shall decide all question of order; shall vote in case of a tie, bu not otherwise; and shall appoint a committees whose appointment is no otherwise provided for.

Sec. 2. Vice President (a) No men ber shall be eligible for the office of Vice President who is not eligible for the office of President. The vice-president shall perform all the duties of the president in the absence or inci-

pacity of the president. and shall have it together with the minute book at all meetings duly treasurer, and keep as a record, the for the various teams. names of all members who have been disfranchised for the non-payment of the books of the Treasurer and the

Sec. 4. Treesurer. (a) The treasurer shall be chosen from the senior class Association at the end of each term. (b). He shall have charge of the gen- It shall have authority also to inspect eral treasury of the athletic association. I the books of any officer at any time,

He shall convey all moneys into the treasury; and on the written order of the chairman of the finance committee, acting for the Commitiee, shall disburse the same. (c). It shall be his duty to collect all fees due to the Association, and to keep a record of the same. He shall have authority to expend such sums as may be necessary for the purchase of stationery for the Association. (d). He shall receive fifty dollars for his services. (e). The Treasurer, before entering upon his duties shall give a bond, the amount of which shall be fixed by the Finance Committee, and the bond must also be approved by the Committee. The Association shall pay all fees necessary for the procurement of the Treasurer's

Sec. 5. Managers of teams. (a). No person shall be eligible to the office of Manager of the football team or baseball team who has not served at least one term as sub-manager. (b). It shall be the duty of the Manager of each team to prepare a schedule of games for his team; to make suitable provision for the comfort of his teams while on its trips; to arrange for the accomodation of visiting teams; to provide for the clothing of his team; and to hold in trust all moneys which may come into his hands; and he shall have authority to expend such sums as may be necessary to meet the obligations incurred by his team. (c). At the end of the season each manager shall turn over to the Treasurer of the Association all the money in his nands, and shall make an itemized statement of all his transactions to the Finance Committee. (d). At least two sub-managers and if necessary more shall be elected by the Association to assist the managers of the football and baseball teams. (e). The sub-managers shall be chosen from the Junior and Sophomore classes.

Sec. 6-Finance Committee.

(A). This Committee shall be composed of five members, two, and only two, of which shall be members of the faculty. The members of this Committee shall be appointed by the President of the Association, acting by and Sec. 3. (B) It shall be the duty of the Ficalled. He shall also obtain from the nance Committee to employ coaches

(C) This Committee shall inspect various Managers at the end of the season, and shall make a report to the Sec. 7-Committee on Rules and Regulations.

(A) This Committee shall be composed of five members, three of whom shall be members of the faculty appointed by the President of the University; and two of whom shall be student members of the Association.

(B) It shall be the duty of this Com mittee to make rules to govern athletics, to determine the elegibility of men desiring to play on the team and to represent the Association in disputes with other colleges as to rules eligibility of players.

Sec. 8-Committee on Recommendation. (A) This Committee shall be conposed of the Finance Committee, the members of the Committee on Rules and Regulations, the President, Vice-President, the Secretary, and the Trea urer of the Association, the Manager of the Football, Baseball, and Track teams, Editor-in-chief of the Tar Heel and the director of out-door athletics.

(B) This Committee shall meet on the fourth Saturday of each month and at such times as the chairman shall call it together.

(C) The Chairman of the Committee on Rules and Regulations shall be exofficio Cl a rman of this Committee.

(D) It shall be the duty of this Committee to consider the general business of the Association, and to make such recommendations to the Association, and to its officers and Committees as may seem to it expedtent; but this Committee shall have no powers other than of recommendation. It shall advise the Association. but shall not act for the Association,

Sec. 9-Committee for Awarding Sweaters.

(A) A Committee for awarding sweaters shall be appointed for each of the teams. Eeach Committee shall consist of the Captain, Manager, and Coach of the particular team and two additional members to be appointed by the President of the Association; one of whom shall be a student and the other a member of the faculty.

(B) Each of these committees shall at the end of the athletic season select such men as have by their atheltic attainments shown themselves worthy of sweaters; and shall report at the last meeting of the Association the number of sweaters and to whom given on the different teams.

Article 6-Amendments.

Sec. 1

The Constitution shall be amended only by a two thirds vote of all the members eligible to vote at a meeting regularly called for amending. But each amendment must be submitted in writing, read before the Athletic Association, and allowed to lie on the table one week before it shall become a part of this constitution.
