## ange Proposed In **Publications' Management**

A change in the business managership of fhe student publications is beg agitated. The following recomindations will be acted upon at a ecial meeting of the Athletic Associa-JII.

.We, the committee appointed by e Fraternities, Societies, and Athic Association to draw up a plan the placing of the college publications upon a firmer business basis, recommend:

rt. 1. Sec. 1. That a permanent asiness manager of college publications, including the Yackety Yack, Tar Heel, and the Magazine, be employed, whose term of office shall t te from the first day August of t'ch year

an auditing committee hereinafter provided for.

Sec. 4. That he be required to sign a contract for three years, rerving to either contracting parts the ght to' terminate the contract upon , months notice.

Art., 2. Sec. 1 That the General jusiness Manager's duties shall be to make all contracts, to solicit all advertising and subscriptions, to perform all other duties relative thereto and which are required of the several business managers as constituted at resent.

Sec. 2. That his powers and obliations shall be the same as those of the several business managers as at present constituted.

Sec. 3. That he be required to give bond to the the auditing committee hereinafter provided for, for 5,000 in some reliable company, the st of said bond to be counted as exinse incidental to managing of the publications.

Sec. 4. That he make an annual itemized report of all business transted for each publication separately

auditing committee and said manager shall be in writing.

Sec. 7. That the auditing committee shall audit all accounts for the previous college year not later than the 15th of September.

Sec. 8. That the auditing committee shall make a report to the Societics, Fraternities, and Athletic Association immediately after the accounts have been audited.

Art. 6. Sec. 1. That the salary of the General Business Manager shall be \$1,000 per annum for the first year in addition to all expenses purely incidental to the managing of the publications.

Sec. 2. That his salary be paid 1.3 the 1st of December, 1-3 the first of April, and the remainder when the Manager's report is approved finally by the auditing committee.

Sec. 3. That his salary shall be Sec. 2. That his official title shall paid by each of the three publications

Sec. 4. That the surpluses and de-Sec. 3. That he shall be elected by ficits that may occur be disposed of by those members on the auditing committee who come from the departments whose publication shows a surplus or deficit.






