WASHINGTON, Dec. 14.—The Brownsville matter was brought up in the senate today in the shape of a message from President Roosevelt including a report made by a special investigator of the war department.

"Who Got The Money?" Delavan Smith Asks Pertinent Question Concerning Panama Settlement. NEW YORK, Dec. 14.—Delavan Smith, of the Indianapolis News, one of the newest members of the Annals Club, would probably have sailed for Havana yesterday on a little pleasure trip but for the controversy arising from President Roosevelt's letter to Dudley Foulke, inasmuch as it is generally understood that the president will spring another letter touching upon the Panama Canal matter within a few days. Mr. Smith desires to be close to the scene of action.
