

It is not infrequent that one hears such expressions as "our representative in the last Legislature passed" such and such a bill. In almost 99 cases out of 100 the Legistature does what the individual representative wants done respecting matters that affect only his own county and for all practical purposes the bills of this class are passed by the individual representatives.
