There are. And there are shoe stores charging \$40 for a pair of shoes. They wouldn't charge such a price for shoes if they didn't know that there are plenty of people willing to pay. As long as there is a demand for ice cream soda at 40 cents a throw, so long we will find accommodating compounders of that soothing alimentive willing to dispense it at the price-or at a dollar, if there are sufficient enthusiasts willing to trade.

We have no kick. Theatres are always crowded; ice crem par lors are busy; cigar stores could, in most cases, handle twice as many lines, and still find a market. It will soon be more of a distinction to be a pedestrian than an automobilist; every month a few more thousands of us climb! in behind windshields and join the speedway parade.
