NEY GENERAL.

In response to a recent Senat Resolution calling upon him for information as to action taken by the Government for the suppression of radicalism throughout the country and asking him to submit draft of a law designed to prevent seditious propaganda and activity of all kinds, Attorney General Palmer has sent to the on the subject and also the draft of a statute which seems fully to meet the needs of the situation.

We quote below the substance of some of the many important statements contained in the Attorney General's report:

At the present time there are 222 radical newspapers published in foreign languages and 106 radical newspapers published in the English language in this country. There are also 144 radical newspapers published in foreign countries which are received and distributed to subscribers in this country. Large numbers of books. pamphlets, and other publications of a radical nature-many of them in foreign languages-also receive wide circulation. These newspapers and other publications openly oppose our form of government and advocate its overthrow by violent and unlawful means.

The radicals are, through these many publications and by various other well-organized means, endeavoring to convert the negroes of the country to their views, and in many respects have already been successful. On this subject the Attorney General says: "There can be no longer any question of a well concerted movement among a certain class of negro leaders of thought and action to constitute themseves a determined and persistent source of a radical opposition to the government and to the established rule of law and order." In pointing out the inadequacy of the present Federal law as a means of dealing with the dangerous situation which confronts the government on account of widespread anarchistic. Bolshevik, and other radical propaganda which is flooding the country. Attorney General Palmer says:

enactment of this proposed law is clearly demonstrated by the Attorney General's report, and it is earnestly to be hoped that Congress will take speedy and favorable action in this matter.




