REVENUE DECISION .- The following extract is from a letter received here by Gen. L. G. Estes, Collector of Internal Revenue for this port, from THOMAS HABLAND, Deputy Commissioner of Internal Revenue at Washington. The letter is in reply to one from General Estes, relative to the enforcement of the revenue tax on liquor dealers in cases where their business had been interfered with by General SICKLES' order. The extract explains itself and reads :


With regard to the claims of Liquor Dealers for the abatement of the special tax, on the ground that their business was closed by General Sickles, Order No. 32, I have to say, that as the assessments were legally made, and the persons engaged in business under them, the taxes cannot be abated in this office; but the remedy for an interruption of their business must be sought at the hands of the military authorities.
