WINDSOR, N. C., 5th Dec. 1893.

The Board met as usual, with the following named members present: J. B. Stokes, Chairman, E. Pritchard, E. E. Etheridge, and Thos. S. Norfleet.

W. L. Lyon, C. S. C., was given until next Monday to report under chapter 580 Laws 1891.

The three official bonds of the Sheriff and Treasurer in the aggregate sum of \$51,000. The Clerk of the Superior Court's bond of \$10,000, and the Register of Deed's bond of \$5,000 were received.
