GREENVILLE - Antonio Tillmon's arraignment, originally scheduled Tuesday along with nine other Operation Rockfish defendants, has been rescheduled for May 10.

While Tillmon sat through the advice of rights Tuesday at the federal courthouse in Greenville, no arraignment was held.

"We are disappointed in the federal trial court's decision because there is so much uncertainty on whether the primary election already under way can continue or whether a new primary election needs to take place and whether votes that have already been cast can be counted," Sen.

Bob Rucho (R-Mecklenburg) and Rep. David Lewis (R-Harnett) said. "We hope the U.S. Supreme Court will recognize the urgency and gravity of these questions and issue a stay."

Those who have fought for the redistricting say that two elections have already occurred since the 2011 redrawing of the maps, and that it is unconstitutional for a third to

be allowed.

While battling to receive a stay from the U.S. Supreme Court, lawmakers are already moving forward with redrawing the districts in case they do not receive a favorable ruling from the court.

Public hearings were scheduled for Monday, with lawmakers planning to return for a special session later this week if the stay is not approved.
