Last Tuesday, voters went to the polls to choose leadership for every town in the county. Unofficial results showed most of the towns maintained their current mayors and commissioners.

The only place changes were made was in the town of Kelford where at least one - and possibly two - new board members were elected. Randy D. Robtov was elected with 29 votes for the Kelford Board of Commissioners while Kenneth Ray Cain, the other newcomer, is tied for the fifth and final seat with incumbent Wayne Bland. Wade "Tim" Emory (35 votes), John "Timmy" Eaton and Jim T. Harrell (25) were each re-elected to the board. Bertie County Elections Director Sheila Holloman said either of the candidates may request a recount to see if the tie can be broken.
