WINDSOR - There will be a race for the Democratic nomination for Bertie County Commissioner in District

Two-term incumbent Commissioner Ronald D. Wesson missioners as no one filed will seek re-election to his

seat, and is being challenged by former Bertie County Board of Education member Pamela Chamblee.

No Republicans have filed for the seat.

There will be no primary for the District 4 seat on the Bertie County Board of Comfor the seat.

Bertie County Elections Director Shelia Holloman confirmed incumbent John Trent has filed a petition to seek office as an unaffiliated candidate. Trent has filed in that fashion both of his previous terms.

Holloman said the petition cannot be certified until January.

Another current Bertie County Commissioner will be on the ballot as well, but not seeking re-election. Ernestine Byrd Bazemore will seek the District 3 State Senate seat being vacated by Erica Smith.

Bazemore is the only Democrat to file and will advance to the November General Election where she will face Republican Thomas S. Hester Jr., a Vance County Commissioner.

The N.C. House of Representatives seat in District 1 will be contested, but not in the March primary. Only Republican Ed Goodwin filed

Prison term set

Lee gets 10 years in federal penitentiary

NEW BERN – A Lewiston Woodville man will be spending the next 10 years of his life behind

Donnell Lee, 42, was sentenced on a combination of charges from multiple arrests.

Lee will spend 128 months behind bars, followed by three years of supervised release under the order of U.S. District Court Judge Louise W. Flanagan.

The case against Lee began to take shape in 2016 when the Bertie County Sheriff's Office began using a criminal informant to purchase heroin from Lee. The informant met with Lee three times at the latter's home on Oak Drive
