During the Aug. 5, 2019 work session, now retired Bertie County Manager Scott Sauer reviewed the latest updates on the proposed study and fee proposal.

Sauer recapped the March 28, 2019 joint special meeting between Bertie, Martin and Chowan county officials as well as the Bertie-Martin Regional Jail Commission.

The estimated cost of the study is \$74,750 or \$24, 917 per county.

### Family Dollar in Colerain robbed, clerk injured

COLERAIN - A clerk was injured during an armed robbery at Family Dollar Friday.

Bertie County Sheriff John Holley said his office was dispatched to the department store shortly after 11:30 a.m. Friday.

"The original call indicated there the scene, but not transported,

had been an armed robbery, and the clerk had been shot," Sheriff Holley said. "Upon the arrival of the first officer, it was found the clerk wasn't actually shot, but was wounded."

Sheriff Holley said one of the suspects had shot bullets into the floor. one of which ricocheted up and caught the clerk on the forearm. She was treated by Bertie County EMS at

The sheriff said two black males entered the store wearing hoodies and masks. They went to the clerk and demanded money.

The two suspects took the cash drawer and fled the store, but Sheriff Holley said they couldn't have gotten away with much in the way of cash.

## **Election** dates near

Voter registraton deadline set for Feb. 7

WINDSOR - There are several key dates coming for the March Primary in North Carolina.

The first is slated for next week, which is the deadline for voters to change their registration or become registered.

The Voter Registration deadline for those making initial registration or changing their records is set for 5 p.m. Friday. Feb. 7.

Less than one week later will begin the absentee balloting and One-Stop Voting. One-Stop is slated to start at 8 a.m. Thursday, Feb. 13. It will continue through 3 p.m. Saturday, Feb. 29.

The last day to request an absentee ballot by mail is Tuesday,

Those who choose to vote on Election Day can do so between 6:30 a.m. and 7:30 p.m. on Tuesday, March 3.

There will be a host of primaries on the ballot for the March 3 ballot.

North Carolina recognizes five political parties, all of which will have a primary ballot in Bertie County. There will also be a nonpartisan ballot for those who choose to vote without party affiliation.
