WINDSOR - As North Carolina officials announced stronger regulations on social distancing, Bertie County officials released good

On Monday afternoon, new stringent restrictions on the number of people allowed to enter establishments retail went into effect at the order of N.C. Governor Roy Cooper.

The same afternoon, Bertie County announced that 10 of the 12 people diagnosed with COVID-19 have recovered and only one case is active. The twelfth person died of the disease.

Early Tuesday afternoon, however, the active cases inched back up as three new cases were confirmed leaving the county with 15 cases, four of which are
