Cooper said. "But to keep moving forward - and to make sure that we keep saving lives - more people need to get vaccinated."

The governor said 7.7 million doses of the vaccine have been distributed, meaning 51 percent of those 18 and up are at least partially vaccinated and 46 percent are full vaccinated.

"I am so proud of the incredible progress we have made in beating back this pandemic," said Dr. Mandy Cohen, N.C. Secretary of Health and Human Services. "Vaccines continue to be incredibly effective at protecting individuals from this terrible virus. And as more and more people get vaccinated, the results show in our stable metrics with lower cas-
