GEORGE WASHINGTON George Washington was born on Friday, Feb. 22, 1732, and died on Saturday, Dec. 14, 1799, at 10:20 p. m. He was a man of powerful physique, being six feet and two inches in height, with eyes of blue and sandy hair. When 40 years of age he weighed 210 pounds. Washington's father, Augustine Washington, was married twice; and it was his second wife, Mary Ball, who was the mother of George. George was born at Wakefield, on the Potomac, 50 miles below Mount Vernon. His parents moved to Mount Vernon in 1735; at that time this location was called Hunting Creek. On January 6, 1759, Washington married Mrs. Daniel Parks Custis, who before her first marriage was a Dandridge. Mrs. Martha Custis was the mother of four children. After fighting against the Indians and French, George made a name for himself as well as the United States, fighting against the British. It was to Washington that the British General, Cornwallis, surrendered at Yorktown, which ended the Revolutionary War. He was elected the first president of the United States in 1789, at the age of 57. After serving two terms he retired to private life as a farmer upon his plantation. George Washington and Martha Washington were Episcopals. Washington was one of the wealthiest men in the entire country. He owned 70,000 acres of land in Virginia and 40,000 in the near west. His estate at death was valued at \$5,300,000. Washington was a great horse-

back rider and athlete; he held the record for the broad jump for many years. His favorite pastime was hunting and fishing. Washington was a slave owner and operated a distillery at his Dugue Run place. Washington's death was due to exposure on December 12, 1799, in a storm while riding over his estate with his managers. He went to bed with a sore throat, followed by an ague. His remains were interred at Mount Vernon. (This history may be a little out of the ordinary rut, but it gives a few facts not often read in the life of Washington. In each Junior Hall in the country the picture of George Washington is found on the charter of the lodge.)
