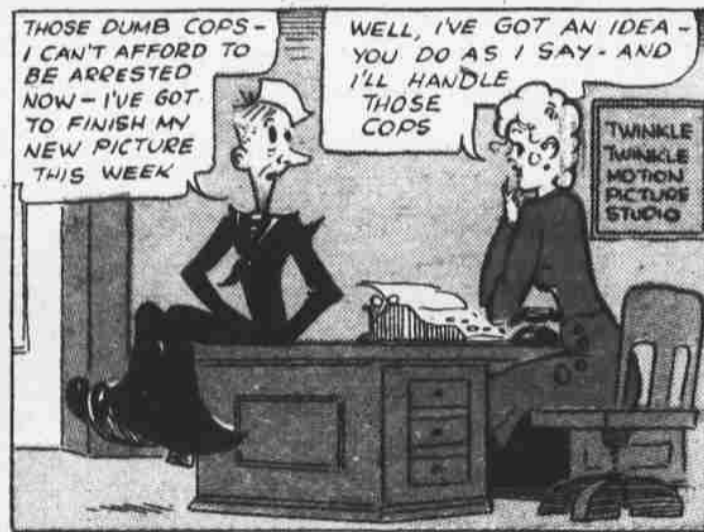

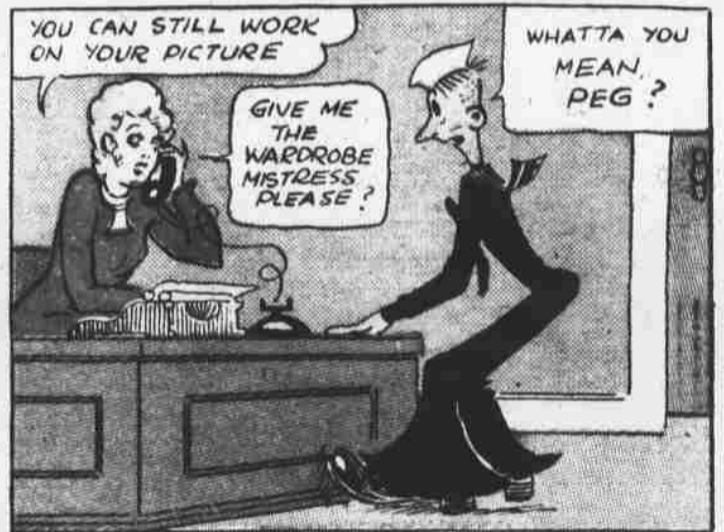
WHY WOULD THE POLICE HOLD DAVEY'S PARROT SO LONG?

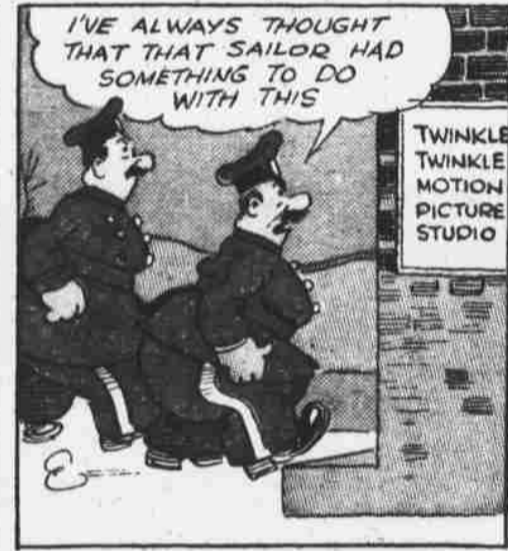

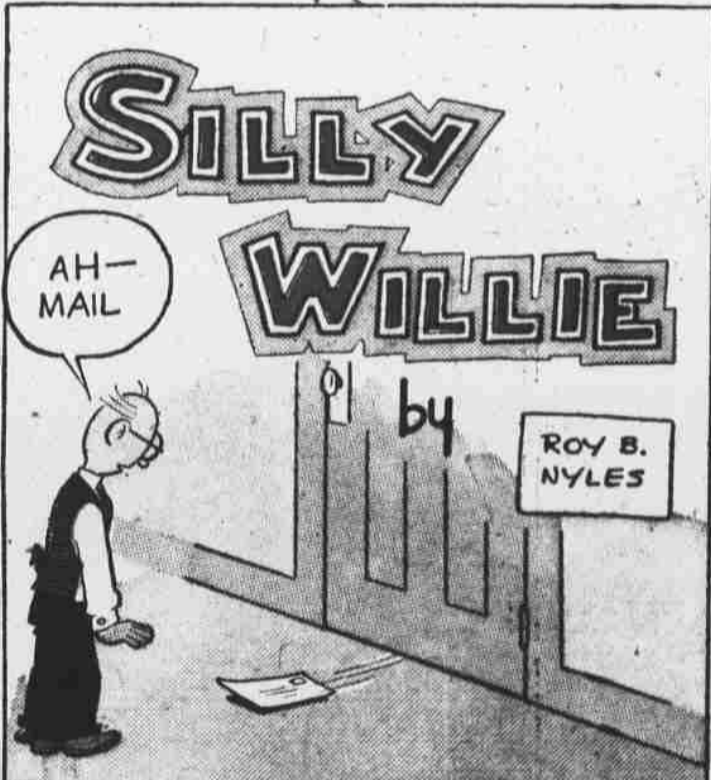

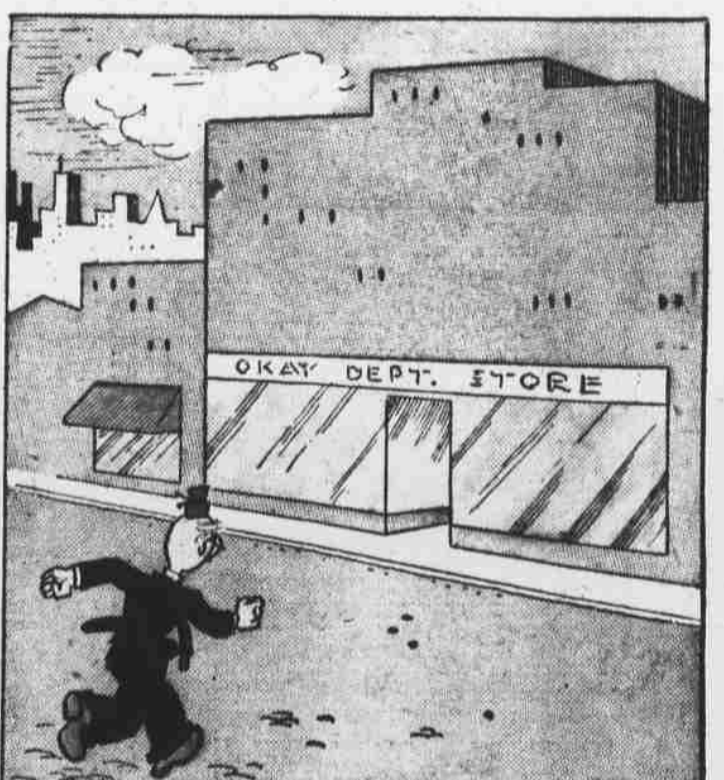
