### Announces Three New Extension Bulletins

The use of auxins in rooting plant cuttings is explained in a new circular published by the State college extension service for distribution to North Carolina farmers.

Soaking the cuttings in indolebutyric acid, known as an auxin, is a big help in propagating plants, as the agid causes cutting to put out more and better roots at a faster

This publication, extension circular No. 221, "Use of Organic Acid in Kooting Cuttings," prepared by J. G. Weaver, assistant horticulturist, with the help of C. F. Williams, associate horticulturist, may be obtained upon request.

The publication of two other new bulletins by the extension service has also been announced.

Dr. Luther Shaw, extension plant pathologist, has explained the need for treating cotton seed to control damping off disease, and shown how the treatment should be administered.

The explanation is contained in extension folder No. 39, "Why and How to Treat Cotton Seed."

Extension circular No. 222, "Ter racing to Reduce Erosion," was prepared by Davis S. Weaver, head of the department agricultural engineering, and H. M. Ellis, extension agricultural engineer.

It points out various methods of constructing terraces on different slopes and soil types, and illustrates the use of light V-drags and heavy terracing equipment.
