

FSA Loans To Macon Farmers Total \$21,000

Small loans totalling \$35,500 have been advanced by the farm security administration to date to farmers in Macon county, William G. Davis, county supervisor, announced. New loans and supplemental loans recently approved for the present year amount to about \$10,250.

The bulk of this money is spent with local merchants of the borrowers' own choice. The money is used for the purchase of plows, horses, fertilizer, seed, breeding stock, fencing, roofing and other items for the repair and improvement of the farm.

In this county 148 farm families are now farming under the rural rehabilitation program of the farm security administration, Mr. Davis said.

The loans are made to worthy farmers who need money to carry on their farming operations but cannot get adequate credit from other sources. The loans are coupled with advice by the county supervisors in good home and farm practices, including a live-at-home program, crop rotation, and soil building. Miss Florence L. Stalcup is the home supervisor assisting Mr. Davis. Their office is located in the new agricultural building.

Amounts loaned for livestock and other capital goods, useful for several years, may be repaid in installments ranging up to five years, while the non-recoverable goods such as seeds and fertilizer are payable in one year.

Smart Poultryman Caters To Market

There are tricks in all trades, even in the poultry business, says C. F. Parrish, poultryman of the State college extension service.

The smart poultryman sizes up his market, and then does his best to meet the consumer demand, Parrish said. For instance, the particular community in which he sells may prefer brown-shelled eggs. In that case, he would select a breed of chickens such as Rhode Island Reds or Barred Plymouth Rocks. On the other hand, if the community preferred white-shelled eggs, he would keep such breeds as White Leghorns or Minorcas.

Then there are tricks in controlling the inner quality of an egg. When chickens are turned on green grass, the yolks of eggs may become extremely bright in color. Naturally, poultrymen selling on a market preferring light-colored yolks will have to make changes in the feeding program.

To lighten the yolks, Parrish advises taking yellow corn out of the

flock's diet and substituting oats, barley, or white corn. Then the amount of time the birds are on the grass should be limited. The effect of this change in diet will show up in the yolk color within a week.

Some markets are more interested in uniformity of yolk color than they are in a particular shade of yellow. That is, Parrish explained, they want eggs all alike in yolk color, regardless of whether the color is light or somewhat dark.

The best way for the poultryman to get eggs with yolks of uniform color is to feed a well-balanced all-mash diet and keep the chickens off the grass range. However, instead of an all-mash diet, a poultryman can feed a grain mixture and a laying mash, provided he uses a grain mixture that supplies about the same quantity of coloring matter as does the mash.

National Forest Timber for Sale

Sealed bids will be received by the Regional Forester up to and including July 13, 1939 for all the live timber marked or designated for cutting, and all merchantable dead timber located on two areas embracing about 3,913 acres within White Oak Creek and Wine Springs drainages, Nantahala River Watershed, Macon County, Nantahala National Forest, North Carolina. The White Oak Creek Compartment includes approximately 2,907 acres and is estimated to contain 8,772 M feet, more or less, of yellow poplar, black cherry, northern red oak, ash, cucumber, basswood, white oak, black oak, chestnut oak, birch, sugar maple, red maple, scarlet oak, hemlock, buckeye, beech, and chestnut, and an unestimated amount of hickory, black gum, silverbell sawtimber, chestnut extractwood, and chestnut oak and hemlock tanbark. The Wine Springs Compartment includes approximately 1,006 acres and is estimated to contain 3,261 M feet, more or less, of yellow poplar, black cherry, northern red oak, cucumber, sugar maple, white oak, red maple, black oak, scarlet oak, chestnut oak, basswood, white ash, birch, hemlock, buckeye, beech, and chestnut, and an unestimated amount of hickory, black gum, silverbell sawtimber, chestnut extractwood, and chestnut oak and hemlock tanbark. The removal of extractwood, tanbark, and hickory, black gum, and silverbell sawtimber on both compartments will be optional with the purchaser. The timber on an additional 804 acres in the White Oak Creek Compartment and 484 acres in the Wine Springs Compartment, carrying a comparatively light stand, may be cut at the option of the purchaser. No bid of less than \$8 per M for yellow poplar; \$7 per M for northern red oak, basswood, black cherry, ash, and sugar maple; \$6 per M for white oak; \$3 per M for birch and red maple; \$2 per M for chestnut oak and black oak; \$1 per M for chestnut, scarlet oak, hemlock, hickory, buckeye, beech, black gum, and silverbell; \$0.50 per unit (160 cubic feet per unit) for extractwood; and \$1.50 per ton (2,000 pounds) for tanbark will be considered. In addition to the price bid for stumps, a deposit of \$0.10 per thousand feet for all timber cut will be required for sale area betterment work. \$2,000 must be deposited with each bid to be applied on the purchase price, refunded, or retained in part as liquidated damages according to the conditions of the sale. 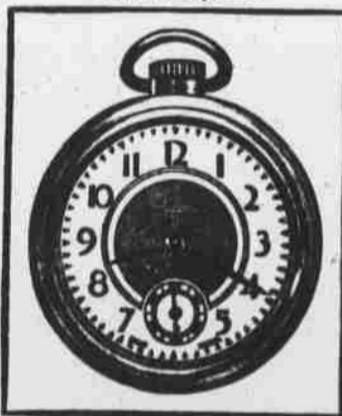
