He suffered a heart attack on his train on April 18, and was taken off the train and placed in a hospital in Morganton where he remained for several days before he was able to be removed to his home.

Mr. Siler who was a son of the late Mr. and Mrs. Arch Siler, of Cartoogechaye, moved to Asheville 44 years ago and had been an employee of the railway for 40 years. He was a member of the Order of Railway Conductors, West Asheville Lodge No. 565, A. F. & A. M., and of the First Baptist church. Surviving are the widow, three sons and two daughters, two brothers, Will Siler, of Robbinsville, and Theo S. Siler, of Franklin, and two sisters, Mrs. G. G.
