

Findlay Asks Cooperation

The future of the wildlife in North Carolina calls for cooperative action.

There is no more serious problem today facing the lover of the out-of-doors than is this subject. Too often in dealing with such an important natural resource as wildlife we are apt to think in terms of one or two years instead of 15 or 20. We forget that generations to come should have the enjoyment of our wildlife heritage just as we have it today. We let personal grievances become paramount and forget the wild animals involved. Speaking bluntly, too often we "can't see the woods for the trees".

In whose hands lies the future of this resource? Under our present state Governmental organization, this is in the hands of the State of North Carolina, under the direct supervision of the game and fish division of the Department of Conservation and Development. The functions of that division are carried on through the use of funds paid in by the hunters and fishermen of North Carolina, and those funds will amount to approximately \$450,000 this year. It is my duty as commissioner of that division to spend these funds wisely and well and I am going to carry out that duty to the best of my ability, regardless of any hindrance, whether deliberate or thoughtless.

Our present program is sound and is as good as the best in this country. It is patterned after what every wildlife administrator knows to be needed in the management of wildlife resources. But will that alone meet the need? Obviously not—the need will be met through the judicious handling of that program, and it is at this point that the future of wildlife conservation in this state hangs in the balance.

I say to you hunters and fishermen—you lovers of the great outdoors—that you can tip that balance. If you get behind this program, regardless of person-
