dry for more than 30 years. The state adopted prohibition in 1908, and the recollection of older citizens here is that Macon had voted dry even earlier, under local option.

It did so, however, only after one or more fruitless attempts of the dries to prohibit manufacture and sale of spirituous liquors. The records in the office of the clerk of superior court show, for example, that in 1881 the voters defeated a prohibition proposal by more than two-to-one. At the election, held August 4, only 257 favored prohibition, while 558 voted against it.
