Preliminary data from the A. 1950 census indicate that only one other state — Mississippi ranks lower than North Carolina in per cent of farms having telephone service. As of April 1, 1950, only 23,347 farms in the Tar Heel state, or 8.1 per cent of the total, had telephone service. The per cent in Mississippi was 6.5. In South Carolina it was 8.5 and in Vir-

ginia, 23.7. For the nation as a whole, the percentage of farms having telephone service in 1950 was 38.3.




