NOTICE

A written petition signed by a majority of the governing board of Southern Pines School District in the County of Moore, and duly approved by the County Board of Education of Moore County having been presented to the Board of Commissioners of Moore County asking for an election on the question of the enlargement of the boundary lines of said Southern Pines School District so as to include in said Southern Pines School District the contiguous territory described and referred to in this petition and it appearing to the board upon consideration thereof that said petition is in due form of law and that the petitioner is entitled to the relief prayed for in the petition, it is hereby ordered by the Board of Commissioners of Moore County that an election be held and the same is hereby ordered to be held in the new territory sought to be added to said Southern Pines School District, on the question of the enlargement of the boundary lines of said Southern Pines School District, so as to include the contiguous territory described in said petition, as provided by law, and said election is hereby ordered to be held upon said question on Tuesday, the 19th day of October, 1926. A Cameron's store is designated as the polling place and Alex Cameron is appointed as registrar and Frank Maples and J. P. Swett are appointed as poll-holders for said election in that territory sought to be added to said Southern Pines School District heretofore known as a part of the Manly School District, which said territory is described and bounded as follows:

Beginning at a stake on the South bank of Mill Creek above the intersection of said Mill Creek with McDeeds Creek, thence S. 46 1-2 E. 1888 feet to a stake, thence S. 14 W. 5963 feet to a stake in the center of the Seaboard Railroad about 120 feet from South West end of Fleet siding, thence S. 56 1-2 E. 15,100 to a stake in Carroll's branch in the Hoke and Moore County line, thence following the said county line 18,795 feet to a stake in the

old Morganton road bed, thence with said Morganton road bed to the corporate limits of Southern Pines, thence with said Southern Pines town line along the northern boundary thereof and with the town line of Jintown to the Morganton road; thence with said Old Morganton road to the Pinehurst School District line; thence with said Pinehurst School District line N. 21 E. 11,050 feet to a stake on corner of said Pinehurst School District in the head of Mill Creek, thence down said Mill Creek to the first station.

J. W. Bethea's store is designated as the polling place and J. W. Bethea is appointed registrar and C. N. Boggan and Evander McIver are appointed poll-holders for that territory sought to be added to Southern Pines School District heretofore known as Jintown, which said territory is described and bounded as follows, to-wit:

Beginning at the run of McDeeds Creek where the Manly School District line crosses said creek above the Yaddin Ford and runs with said district line to line of J. B. Wicker's land, thence Southwesterly to old Morganton road; thence with said road to Southern Pines Corporation line; thence with said line North West to McDeeds Creek; thence down said creek to the beginning.

M. N. Sugg's residence is hereby designated as the polling place and M. N. Sugg is appointed as registrar and D. C. Lemons and B. Weather-spoon are appointed poll-holders for that part of said new territory sought to be made a part of Southern Pines School District heretofore known as a part of Aberdeen School District, which is described and bounded as follows, to-wit:

Beginning at a stake in the Mineral Springs township line where said township line crosses the old Morganton road; thence South 2" West 6500 feet to a stake, thence South 77 East 26,400 feet to a stake in the Hoke County line; thence on said Hoke County line North 44 1-2 East 3200 feet to a stake in said Hoke County line in the center of the old Morganton road bed; thence following the various courses of said old Morganton road to the first station.

An entire new registration of the qualified voters in said new territory sought to be added to Southern Pines School District is hereby ordered in the respective portions of said new territory hereinbefore designated and it is ordered that notice of said election be given by publication of this order at least three times in the Sandhill Citizen and The Pilot, weekly newspapers published and circulated in said territory, the first publication to be made at least thirty days before said election and that notice of said new registration be given by the publication of this order in said Sandhill Citizen and The Pilot at least twenty days before the close of the registration book for said election as hereinafter more particularly designated. The books will be open for registration of voters in the portions of the new territory sought to be made a part of Southern Pines School District hereinbefore described respectively, on the 18th day of September, 1926, at nine o'clock A. M. and will remain open from said date between the hours of nine A. M. and sunset upon each day until and including the 9th day of October, 1926 at sunset of said day, and said books will likewise be open for the registration of voters during the times aforesaid at the respective voting places heretofore named for the respective territories heretofore described on the following Saturdays during said registration period, Saturday, September 18th; Saturday, September 25th; Saturday, October 2nd; Saturday, October 9th. At said election those who are in favor of the enlargement of the boundary lines of Southern Pines School District so as to include in said district the contiguous territory hereinbefore described so as to make said Southern Pines School District a territory, the boundaries of which after enlargement are as hereinafter described, shall vote a ticket on which shall be printed or written the words "For Local Tax," and those who oppose the same shall vote a ticket on which shall be printed or written the words "Against Local Tax." At the close of said election the respective registrars and poll-holders of the respective territories aforesaid shall count, canvass and judicially determine the result of said election in their said respective voting precincts and make returns thereof to the Board of Commissioners of Moore County. Said election shall in other respects be held in accordance with the law governing general elections. If a majority of the qualified voters in the respective voting precincts hereinbefore described in said new territory shall vote "For Local Tax," the different portions of said new territory as aforesaid set forth shall become a part of said Southern Pines School District and subject to all the levies of tax authorized, required and provided for Southern Pines School District as it now exists and thereupon Southern Pines School District shall be composed of and constitute the territory particularly described and bounded as follows, to-wit:

Beginning at a stake in the Mineral Springs Township line where said township line crosses the old Morganton Road and running thence S. 2 W. 6500 feet to a stake; thence S. 77 E. 26,400 feet to a stake in the Hoke County line; thence with the Hoke County line in a North Easterly direction

about 21,995 feet to a stake in Carroll's Branch where it crosses Hoke County line; thence N. 56 1-2 W. 15,100 feet to a stake in the center of the Seaboard Air Line Railroad about 120 feet from the South West end of Fleet Siding; thence North 14 East 5963 feet to a stake; thence N. 46 1-2 W. 1888 feet to a stake on the South bank of Mill Creek above the intersection of said Mill Creek with McDeeds Creek; thence up said Mill Creek as it meanders to a stake a corner of Pinehurst School District in the head of Mill Creek; thence South 21 West 11,050 feet to the Morganton Road, a corner of the Pinehurst School District line; thence with the old Morganton Road North 80 W. 3000 feet to the beginning.

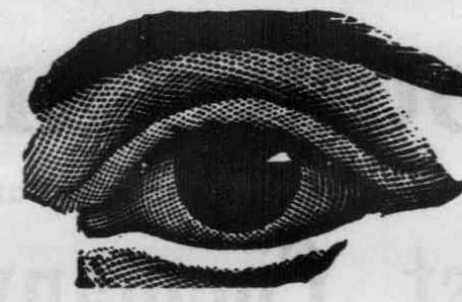
