

Friends and Admirers Pay Fine Tribute to George T. Dunlap, Jr.

Dinner Tuesday in His Honor at Country Club Was Delightful Occasion

A blonde youth who came to Pinehurst at the age of one year, started playing golf at seven and won his first tournament before he reached his teens was hailed as amateur golf champion of the United States before an assemblage of some 200 friends and admirers in the ballroom of the Pinehurst Country Club Tuesday evening.

George T. Dunlap, jr., was guest of honor in the club where he learned the game that has carried him to the pinnacle of American amateur golf-dom.

But George, jr., proud as he may have been of the honor bestowed upon him, was not the proudest man there. But a few feet away from the national champion at the speakers' table sat an older gentleman fumbling a miniature putter. A smile of pardonable pride wreathed his face as speaker after speaker paid high compliment to the tow-headed youngster who's been batting balls around the Pinehurst courses some two decades. Yes, Daddy Dunlap was there—and with him the diminutive club he purchased for his boy in a New York department store when Junior was barely emerging from his cradle.

It was a nice party, this banquet to Pinehurst's returning hero. Since winning the national championship at the Kenwood Country Club in Cincinnati, Ohio, last September his friends in the Sandhills have been planning some sort of a gathering in his honor. When recently young George moved down to Pinehurst for the winter the idea took definite form. And it culminated in a rousing welcome Tuesday night.

At Speaker's Table

At the speakers' table were the George T. Dunlaps, sr. and jr., Leonard Tufts, Elvin N. Edwards, district attorney of Nassau county, New York; William C. Fownes, jr., former U. S. amateur golf champion; O. B. Keeler of the Atlanta Journal, Atlanta, Ga.; Donald J. Ross and Richard S. Tufts. Richard Tufts, after calling for a song written for the occasion, "Champion George," introduced Mr. Keeler, familiarly known as "Bobby Jones' Boswell," as toastmaster. In his introductory remarks Mr. Tufts spoke of the preeminence of golf at Pinehurst, of the influence of Donald Ross on the development of the game here and throughout the country, and of the effect both these points had in creating the game which last September won the national amateur crown in Cincinnati.

Mr. Keeler introduced District Attorney Edwards who thrilled his listeners with tales of criminal cases which had come under his jurisdiction, particularly the case of "Boston Billy" and his conquest of the millionaire golfers of Florida with whom he used to battle on the links by day and deprive of their jewelry and wealth at night.

"Beware of the golfer who plays in the 70s, particularly if you are a millionaire," was Mr. Edwards' advice to the crowd. "If you're the other kind of a golfer, my kind, you have nothing to fear. In all my experience as district attorney I have never seen a dub golfer 'sent up,'" he said.

Donald Ross gave the recipe for the success of golf in Pinehurst. "Build courses for 90 per cent of the golfers, not for 10 per cent," he said. "Too many courses are built for the small minority that shoot in the seventies and low eighties. We try to make our courses as pleasant as possible for all to play on and enjoy."

William C. Fownes, jr., was introduced by Mr. Keeler as having done more for the present game of golf than any other president of the United States Golf Association. Mr. Fownes was president of the national body for several years and was national champion in 1910. He told of George Dunlap's victory in the National Intercollegiate in 1930 and his march of progress in the game since then.

Mr. Dunlap, sr., told something of his son's start in golf, and what a close call it was that George, jr., wasn't a left-handed dub today instead of national champion. It seems that when that first putter was turned over to the lad he insisted upon swinging it from the port instead of the starboard. To correct this Mr. Dun-

Appalling Toll

Recklessness and Drunken Driving in State Must Stop, Says Governor

Governor Ehringhaus has issued a statement on automobile accidents in North Carolina, as follows:

"The constantly mounting toll of recklessness in the use of our highways is appalling; 105 killed, 527 injured, 40 of the killed and 75 of the injured being pedestrians, is the record for November in our state. Such charge equals that of war and amounts to a public scandal and disgrace. Our highways intended as a means of convenience and pleasure to our citizens, are becoming a menace.

"Recklessness and drunken driving must be stopped. I am directing our Highway Patrol to begin at once a most vigorous campaign against such drivers in our state and I am calling upon all law enforcement officers to cooperate fully and effectively on this enterprise. At the same time I beg the cooperation and sympathetic assistance of our law abiding citizens in clearing the highways of dangerous drivers. The lives of innocent men, women and little children must not be endangered by the reckless indifference of a relatively few who abuse the privilege the State provides them. Let us see what a month of real effort can do toward checking this bloody tide."

lap bought the boy a right-handed wooden club. He couldn't hit the ball left-handed with that, so the day was saved. No left handed golfer has ever attained an important championship.

Mr. Keeler glowingly described the guest of honor's brilliant golf game in his introduction of George, jr. Calling him "the blonde D'Artagnan of Golf," he ranked him with his own beloved Bobby Jones and predicted that George was going a long way yet. His 68 in the final round at Cincinnati has been equalled in the amateur finals only by the great Bobby, he said, "and I'm not so sure but that George's round was over a stiffer course than Bobby's. He said the game had no better putter today than Dunlap, and ascribed much of the success of his accuracy to his daddy, "whose 150-yard drives were always straight down the course."

The national champion, with becoming dignity expressed his appreciation to those who had arranged the dinner in his honor, and thanked all for their kindly expressions and sentiments.

Mr. Keeler paid high tribute to Pinehurst as "the greatest golfing center in the world, the greatest resort in the world," in introducing the final speaker, Leonard Tufts. Mr. Tufts spoke briefly in behalf of his own pet course at Pinehurst, the No. 1 course. "Someone," he said, "played the No. 2 course in the morning, the No. 1 in the afternoon, the other day, and told Donald Ross the No. 1 course was like comic opera after the grand opera of No. 2. I consider this libelous," he said, "especially as I have been fighting to keep the No. 1 course from being changed for years. It's the one course I have had anything to do with."

Moving pictures of the championship won by Dunlap in September were shown after the completion of the toast list. During the splendid dinner served by C. L. Lyman, steward of the Country Club, Charlie Picquet led singing to the accompaniment of Howard Lanin's orchestra. The attractive menu cards were featured by photographs of the champion taken in December, 1920, when he won his first Pinehurst tournament, the Junior Boys' event, one when he won the Mid-winter tournament here in 1933 and one taken holding the Havemeyer Trophy, emblematic of the national amateur championship. In his use to the national title George Dunlap won 26 tournaments on Pinehurst courses, and was the medalist in 14 events.

The dinner was attended by large numbers of cottage residents of both Pinehurst and Southern Pines, by many guests in the hotels and many of the permanent residents of the section.
