Unlicensed Seller of Magazines Case Heads Recorders Court

The trial of Miss Thelma Flannagan, of Charlotte, a professional seller of religious literature issued by the Seventh Day Adventist denomination, has been continued to Monday, April 30. Represented by two Charlotte attorneys in Moore County recorders court on Monday of this week, she pled not guilty to charges of "selling and offering to sell to the public periodicals without first obtaining a license as required by law."

Miss Flannagan was arrested in Southern Pines April 9.

Judge J. Vance Rowe, presiding at the regular weekly session. of the court at Carthage, continued the case to April 30 to allow attorney's for the defense, as well as the court's solicitor, to file briefs. A decision is to be render-Monday, Judge Rowe said.

According to evidence presented in court Monday, the organization by which Miss Flannagan is employed had a state-wide license to sell periodicals that expired March 1. 


